| 19 | A My position, without clarification, would be that |
| 20 | that money was to stay in Monroe County. |
| 21 | Q Ms. Limbert-Barrows showed you a letter from |
| 22 | Roman Gastesi to the Clerk Of Court, Danny Kolhage, |
| 23 | initiating the formal audit process? |
| 24 | A Yes. |
| 25 | Q Do you recall the meeting with Mr. Kolhage, Mr. |

| 1 | Gastesi, prior to that letter being issued? |

| 3 | time. In reference to this audit? |
| 4 | Q Yes. |
| .5 | A I don't think so. |
| 6 | Q Does that change your recollection about why the |
| 7 | audit of SUFA was requested, from your prior testimony? |
| 8 | A Yeah. I think that I think this clarifies who |
| 9 | and why it was requested. I forget exactly what my |
| 10 | response was to your question. But, as I said, my memory |
| 11 | was washed on this. |
| 12 | Q Well, you testified at length about the fact that |
| 13 | Ms. Gottwald requested a 23 percent increase in the annual |
| 14 | compensation as one of the reasons that triggered the |
| 15 | audit. Is that you're no longer saying that? |
| 16 | A Did she make that request, prior to July 8th? |
| 17 | Q I don't know. |
| 18 | A I don't know either. |
| 19 | Q I'm asking you. You're the one that testified |
| 20 | about it. |
| 21 | A I'm the one that said that I thought that that's |
| 22 | what triggered Ms. Gottwald this audit taking place. I |
| 23 | don't know, now, based upon what I'm reading in this |
| 24 | letter, the chronology of that situation of which came |
