A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, THANKING THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) SECRETARY FOR HIS PERSONAL INVOLVEMENT; PROVIDING INPUT TO FDOT REGARDING ITS PROPOSED MAINTENANCE OF TRAFFIC PLAN (MOT) TO BE IMPLEMENTED DURING CURRENT AND FUTURE PHASES OF THE CONSTRUCTION OF NORTH ROOSEVELT BOULEVARD; REQUESTING FDOT TO PROCEED EXPEDITIOUSLY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Florida Department of Transportation is in the process of a comprehensive reconstruction of North Roosevelt Boulevard; and

WHEREAS, on August 6, 2013, FDOT Secretary Ananth Prasad hosted a public meeting and presented options to adjust the construction timeline, and the flow of traffic on North Roosevelt Boulevard, to complete the project in an expeditious manner; and

WHEREAS, at the meeting, numerous citizens and business owners spoke about the construction and the plans to adjust the MOT; however, the City Commission took no formal action regarding an amended MOT; and

WHEREAS, the City Commission desires to formally discuss the impacts to public safety and the duration of the project envisioned by the implementation of a two way traffic plan.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Commission hereby recognizes and thanks Secretary Ananth Prasad for his personal involvement and concern for the impacts North Roosevelt reconstruction has had on the residents, businesses and visitors to the City of Key West;

Section 2: That the City Commission is concerned with the potential impact to public safety caused by two way traffic without a center turn lane. The City Commission desires that the results of the public discussion and vote held on August 20, 2013 be presented to FDOT for consideration.

Section 3: That FDOT is hereby urged to proceed with the road and sidewalk construction safely and expeditiously.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the

Commission.
